- 4. Actions arising from the minutes -
 - **Mobile phone coverage** responses from Fiona Phillips and Michelle Rowlands (Communications minister) re federal government support for remediating mobile black spots.
 - **Action** Michael Shaw to request Telstra, Optus and TPG to include our area in their Black Spot grant applications
 - Illegal use of fireworks Michael Shaw has written to RFS, police and Council re their advice on response to this problem
 - Community usage of old Manyana fire station Chris Hayes has spoken to a council officer re Council intended usage of the site. Nothing considered at this stage.
 - **Action** RHVA to write to Council to formerly request their consideration of community usage of the site
 - Overgrown verges on Bendalong and Inyadda Rds response from Council that these will be mown in May
 - Illegal overnight camping in beach public car parks letter written to Council about community concerns that no action taken by Council rangers. No response to date.

 - Board walk request near cnr Manyana Dr and Sunset Strip, and historic grave site on Inyadda Dr bush land crossing upgraded by community member across the creek. Site review by Neil McGuckin and Kerry Moore. Board walk not considered appropriate for the site. Basic clean up of historic grave to be actioned

- Stingray tourist impact at Boat Harbour letter written to Fisheries NSW response specific to impact by recreational fishing. Sign installed but advice not relevant to general impact by tourists. Potential for grants to erect interpretive signage.


